Charity, The First Principle of our Order

Dear Brother Knights,

As I wrap up my second month as your Grand Knight, I plan to write a series of newsletter articles on our four principles of Charity, Unity, Fraternity and Patriotism. The first and foremost principle of our Order is Charity, the greatest of all virtues and the crowning glory of a Christian life. It is simply what we are called to do. With these articles, I hope to encourage all of us to continue to grow in our faith and support our communities, parish and each other. I will do my best to summarize how we are all making a positive impact as Knights of Columbus and specifically, how we are supporting our commitment to Charity.

First, let us all reflect on our global impact. According to the 2022 Annual Report of the Supreme Knight, more than 2 million Knights around the world serve and sacrifice for others. We donated nearly **\$154 million** to worthy causes and volunteered close to **48 million hours**. That means that each Knight donated an average of **\$77** and volunteered an average of **24 hours**.

Next, let's look at the State of Arizona, where we have over **18,500 Knights**. Collectively, in 2022, we donated **\$1.84 million** and **390,665 volunteer hours**. Per Knight, that's an average of **\$99** and volunteered an average of **21 hours**.

Of course, let's look at our small but mighty Council 15001. Last year, our Council donated **\$17,400** and over **7,500 volunteer hours**. Our total **membership is 105 Knights**, so that's an average of **\$166 donated per Knight** and **71 volunteer hours per Knight**. These are impressive numbers, indeed. Here is a breakdown of how we distributed the \$17,400:

[What does it actually mean to have faith?](#)

“We must place our faith in Christ in order to allow him to save us. But what does it actually mean to have faith? What does it look like? Does it mean you just "agree" with everything Jesus and his Church say? Or is it deeper than that?”

Today, Fr. Mike draws a sharp distinction between faith and mere "agreement", and calls us to a more radical trust in our savior.

As Knights of Columbus members of St Paul's Council 15001, we need to take 9 minutes out of our busy days and listen to this video by Fr Mike which provides an important perspective on this important question. I have included some quotes from the video below so you can get a glimpse into his message. Please watch the full video to get the whole story and then share it with your loved ones!!!

“We have Catholics who stand up every single Sunday and every single Sunday we will profess the faith right. We'll even start with I believe what I might be declaring is *I declare that I agree with all of these propositions about God. I agree with all these propositions about who God is, I believe with all these propositions about what God has done, and I believe, I agree with, all these propositions about what God is doing in our lives right now. I agree in the Holy Spirit, I agree with the belief in Jesus the son of God, I agree with the statement that God himself is one right and I'm just agreeing with propositions.*”

“Is that faith -- I would answer no! I would say it's maybe the beginning of faith but that's not Faith! Why not? Let's go through this because if I'm simply believing in propositions that means that I intellectually have come to a place of belief which is great -- really wonderful -- but faith is deeper! **Faith officially can be defined as when I submit or I Surrender my intellect and my will to God himself!** Faith is when I submit my intellect and my will to God himself that means to what he's revealed about himself, to me, about creation, about how to get close to him, about salvation, about justification, and about how we get Holier and Holier like all these pieces. I've submitted my intellect and my will to God himself is faith and agreement is I agree with these propositions and so that doesn't necessarily make an impact on How I Live! That isn't even a surrender of my intellect or a submission of my intellect to God himself that simply means I agree with these propositions about God.”

“There are a couple dangers here—the first danger is if my faith quote-unquote faith is simply agreement what happens when I come upon a proposition that you can't convince me about like what happens when I come upon a proposition that I'm like that doesn't make any sense to me -- well then I don't agree with this proposition and so what I call Faith is not in a person, my faith is in a proposition and that agreement is tenuous it's fragile at best”

“The work of theology is a deeply intellectually rigorous asking really hard questions that is Faith seeking understanding so please don't misinterpret me as saying don't ask questions that we're asking questions is really really good but we have to ask questions like the Saints asked questions. They were Relentless in pursuing the truth until they had some kind of answer and they were willing to let God tell them that's the big thing that's the difference between a lot of us and the saints that when I'm like, wait God prove it to me, I'm demanding an answer versus the Saints who are wrestling and saying this is so important I've got I want to understand you and so as they're asking the question, they're asking the question not as a skeptic, and not as a cynic but as someone who pursues truth and will not give up asking the question until they have grasped the truth in some way -- why -- because if theology is faith-seeking understanding, faith is what faith is when I've submitted my intellect and my will to God himself.”

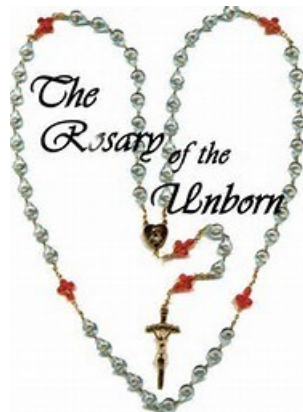
“I agree with a proposition. I have faith in a person! If I have faith in a person like I have faith in God himself I have faith in the Father, Son and Holy Spirit. That means that yes I agree with these propositions—you want to stand up and recite the Creed

Yeah, I'm saying yeah! I believe in all these things about God but here's the thing, I have a relationship with that God! This is the big danger about simply agreeing with propositions is it has like a pseudo relationship where it's actually God and I are not connected, we're not in relationship with each other -- it's I simply believe a bunch of things about him but faith is -- I trust him -- faith is I've surrendered to him not just to a bunch of propositions. Faith is I've surrendered my intellect and my will. I've surrendered my whole self to him and this is the distinction so that when I run up against a big question whether I'm six years old or 66 years old when I'm up against a big question I can wrestle with it and I can ask the question, and I can even be troubled by it but the relationship -- the relationship is the driver behind the whole thing"

"God I believe -- help my own unbelief -- God I love you -- help the parts of me that don't love you -- God I belong to you -- help the parts of me that hesitate to belong to you! Too often when we recite the Creed, when we check the box and say yeah I'm Catholic -- they were saying I agree with these propositions now that is vital that is necessary -- but faith is salvific and faith working yourself out in love is relational. God doesn't just want you to have a bunch of propositions that you agree to -- he wants you to have a relationship with him and that's faith!"

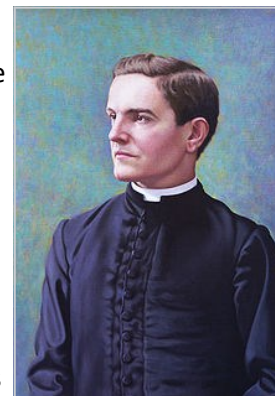




Who Was Fr. Michael McGivney?:

It is so easy to become a Knight of Columbus and keep hearing about Fr. Michael Fr. McGivney, but who was he really?

Michael Joseph Fr. McGivney (August 12, 1852 – August 14, 1890) was an Irish-American Catholic priest based in New Haven, Connecticut. He founded the Knights of Columbus at a local parish to serve both as a Christian and also as a mutual aid and fraternal insurance organization, particularly for Immigrants and their families. It developed through the 20th century as the world's largest Catholic fraternal organization.



In 1868, at the age of 16, Michael McGivney entered the Séminaire de Saint-Hyacinthe in Saint-Hyacinthe, Quebec, Canada. He continued his studies at Our Lady of Angels Seminary, near Niagara Falls, New York (1871–1872) and at the Jesuits' St. Mary's College, in Montreal, Quebec. While in the seminary, he and other seminarians formed a baseball team and Michael was a "naturally talented ballplayer. But, he had to leave the seminary, returning home to help finish raising his siblings after his father's death in June 1873. However, Fr. McGivney later resumed his studies at St. Mary's Seminary, in Baltimore, Maryland and he was ordained a priest on December 22, 1877, by Archbishop James Gibbons at the Baltimore Cathedral of the Assumption.

Founding of the Knights of Columbus

From his own experience, Fr. McGivney had recognized the devastating effect on immigrant families of the father and wage earner's untimely death. Many Catholics were still struggling to assimilate into the American economy. On March 29, 1882, while an assistant pastor at Saint Mary's Church in New Haven, Connecticut, Fr. McGivney founded the Knights of Columbus, with a small group of parishioners, as a mutual aid society, to provide financial assistance, in the event of the men's deaths, to their widows and orphans. The organization developed as a fraternal society. Fr. McGivney was also known for his tireless work among his parishioners.

Fr. McGivney spent seven years at St. Mary's, then became pastor of St. Thomas Church in Thomaston in 1884. He died from pneumonia at the age of 38 in Thomaston on the eve of the Assumption in 1890.

The Knights of Columbus was among the first groups to recruit blood donors, with formal efforts dating to 1937 during the Great Depression. As of 2013, the order had more than 1.8 million member families and 15,000 Councils. During the 2012 Fraternal Year, the order donated \$167 million and 70 million man-hours to charity.

By 2020, the order reached the 2 million member mark. During the 2019 Fraternal Year, the order donated \$187 million and 77 million man-hours to charity.

Cause of beatification and canonization

In 1996, the Roman Catholic Archdiocese of Hartford opened the cause for canonization, an investigation into Fr. McGivney's life with a view towards formal recognition by the Catholic Church of his sainthood. Gabriel O'Donnell is the postulator of Fr. McGivney's cause. He is the director of the Fr. McGivney Guild, having 150,000 members supporting his cause.

The diocesan investigation closed in 2000, and the case was passed to the Congregation for the Causes of Saints in Vatican City. On March 15, 2008, Pope Benedict XVI approved a decree recognizing Fr. McGivney's heroic virtue, thus declaring him as "Venerable".

As of May 5, 2015, a miracle attributed to Fr. McGivney's intercession was under investigation at the Vatican. On May 27, 2020, the miracle attributed to the intercession of Fr. McGivney was approved by Congregation for the Causes of Saints and authorized by Pope Francis. The Miracle involved the healing of Michael "Mikey" Schachle in his mother's womb after being given a zero percent chance of survival by doctors at Vanderbilt Medical Center in 2015.

On October 31, 2020, the beatification Mass of Michael Fr. McGivney was celebrated at the Cathedral of Saint Joseph in Hartford, Connecticut with Cardinal Joseph W. Tobin presiding on the Pope's behalf.

The cause for his canonization started in the Archdiocese of Hartford in 1996; in March 2008, Pope Benedict XVI declared Fr. McGivney "Venerable" in recognition of his "heroic virtue".^[1] On May 27, 2020, Pope Francis announced that Fr. McGivney had been approved for beatification, which officially occurred on October 31, 2020.

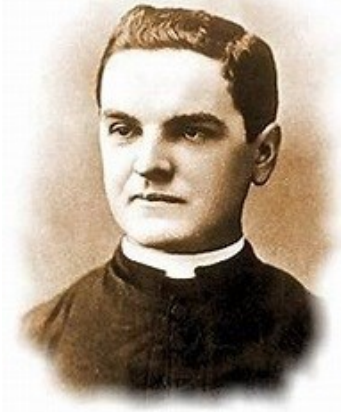

It was especially important this year as he is still considered "blessed" by the Vatican and awaits the recognition of one more miracle before he is declared a Saint. Let's Pray the Rosary, Arizona!

The planning for upcoming 2023 Arizona Rosary Celebration is underway. This year's celebration will honor Mary under her title of Our Lady of Mt. Carmel. The Phoenix Celebration is scheduled for October 15, 2023 at the Phoenix Convention Center. Our Lady of Mount Carmel or Virgin of Carmel, is the title given to the Blessed Virgin Mary in her role as patroness of the Carmelite Order, which is particularly done within the Catholic Church. The first Carmelites were Christian hermits living on Mount Carmel in the Holy Land during the late 12th and early to mid—13th century. They built in the hermitages a chapel which they dedicated to the Blessed Virgin, whom they conceived of in chivalric terms as the "Lady of the Place." Our Lady of Mount Carmel was adopted in the 19th century as the patron saint of Chile.

Since the 15th century, popular devotion to Our Lady of Mount Carmel has centered on the Scapular of Our Lady of Mount Carmel, also known as the Brown Scapular. Traditionally, Mary is said to have given the Scapular to an early Carmelite named Simon Stock (1165–265). The liturgical feast of Our Lady of Mount Carmel is celebrated on July 16th.
